The Dunwoody Police Department has arrested Mr. Kalijuan Hawkins, age 19, of Dunwoody for the death of Mr. Spencer Lavest Foster. Mr. Hawkins was taken into custody on May 8<sup>th</sup>, 2020, charged with felony murder, and is currently at the DeKalb County Jail. Any further inquiries regarding this case should be directed to the DeKalb County District Attorney's Office.

The victim has been identified as Mr. Spencer Lavest Foster, 39-years-old, of Dunwoody. Mr. Foster's death has been ruled a homicide and the investigation is underway.

On May 6, 2020 at 6:43 PM, the Dunwoody Police Department received a 9-1-1 call regarding a person possibly deceased inside an apartment at the Dunwoody Village Apartment Homes. Officers arrived and located one adult male deceased.

Possible signs of foul play were observed within the apartment and Dunwoody Police investigators are working with the DeKalb County Medical Examiner's Office to determine the cause and manner of death.

The identity of the decedent will be released at a later date once appropriate notifications have been made.
